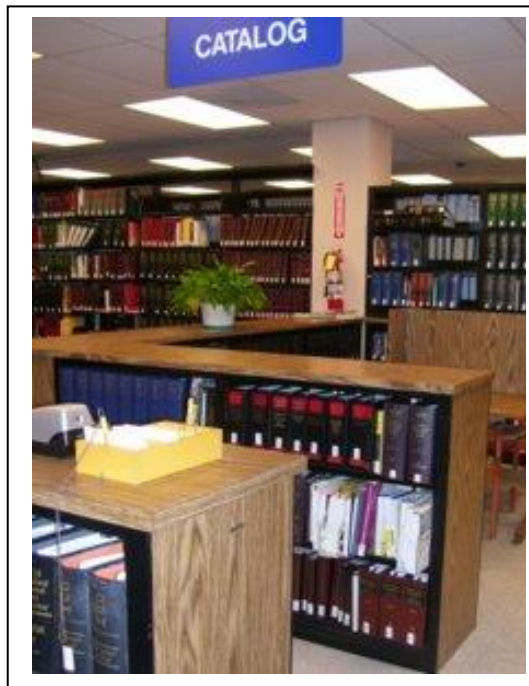

New Law

A new law extends the reach of a restraining order. This new law, chapter 258E of the General Laws, is for victims of harassment that are often not persons covered under our existing 209A protective restraining order statute.

This order can be issued against people who are not domestic partners or family members. Violations of a protective order are criminal offenses.
